
**RELATING TO THE FUNDING OF THE
HYPER-REACH MASS NOTIFICATION SYSTEM**

THIS INTERGOVERNMENTAL AGREEMENT is made as of October 1, 2018 (the "Effective Date"), by and among the County of Union, Illinois, a body politic and corporate, ("Union County"), Union County Sheriff's Department ("Sheriff"), Union County 9-1-1 ("9-1-1"), Union County Ambulance ("Ambulance"), the City of Anna, Illinois, ("Anna"), the City of Jonesboro, Illinois ("Jonesboro"), the Village of Cobden, Illinois ("Cobden"), the Village of Dongola, Illinois ("Dongola"), Anna-Jonesboro High School, Anna Jr High School, Dongola School, Lick Creek School, Shawnee School, Tri-County School, Cobden School and Jonesboro Elementary School and together with Union County, the "Parties".

WHEREAS, pursuant to Article VII, Section 10 of the Illinois Constitution of 1970, and 5 ILCS 220/1, *et seq.*, the Parties are authorized to enter into an intergovernmental agreement;

WHEREAS, the Parties find it is in the best interest of the residents of Union County, Anna, Jonesboro, Cobden and Dongola to efficiently notify the citizens of Union County in the event of a public safety emergency.

WHEREAS, "Parties" desire to jointly assist Union County in funding the Hyper-Reach Mass Notification System.



NOW, THEREFORE, in consideration of the foregoing recitals and the mutual covenants and promise contained herein, the sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

- (1) The Parties shall fund the Union County Hyper-Reach Mass Notification System according to the attached Exhibit "A". **Payments made under this Agreement shall be due on/before November 1, 2018** and shall be paid to the Union County Treasurer.
- (2) The term of this Agreement shall be from the Effective Date through September 30, 2019.
- (3) If any provision of this Agreement is held to be invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provision shall not be affected.
- (4) This Agreement, including the rights, benefits and duties hereunder, shall not be assignable by any Party without the written consent of the Parties.
- (5) The Parties may execute this Agreement in counterparts, each of which is deemed an original and all of which only constitute one original.
- (6) In the event of a new participant to the agreement, an addendum will be attached and the amount will be prorated to reflect a credit to each existing entity.
- (7) Any entity who chooses not to renew the agreement must give a minimum of ninety (90) days' notice in writing to the Union County Sheriff.
