

On, 07-10-19, I, Deputy Ralls UC K9-1, responded to 1825 Bald Knob Cross Rd (Broken Wheel Ranch), for a report of a burglary.

I made contact with the property owner, Jason Seagle, he advised me that six of his cabins had been broken in to and items had been taken from the cabins. I was escorted by Jason to one of the cabins, he pointed out some tool marks on the door and frame, we entered the cabin and I noticed some wiring and copper pipe hanging from the wall, I was advised by Jason that a water heater had been located in that spot and it was missing, he also stated that a microwave and flat screen television were also missing from the cabin. I was advised by Jason that the other cabins had the same tool marks and the same items missing from them, he did advise that one of the cabins also had a window air conditioner missing from a window. I did not walk in to any of the other cabins due to the fact that crime scene would respond and process the buildings.

I was advised by Jason that the items he knew were missing were, 4 microwaves, three white and one black, 1 Samsung and 1 Emerson brand, he did not know the brand of the other microwaves, 4 flat screen televisions, 2 Vizio and 2 Samsung, 7 water heaters, unknown brands. I was advised by Jason that there were 2 picnic table missing from the property also. The approximate value of the stolen items is \$ 6,100.00. There were no serial numbers listed for any of the items.

I contacted Illinois State Police Crime Scene and advised them of the burglary, I was contacted by Crime Scene Technician Matt Deschamps, he responded and processed the scene, the evidence was collected and I placed it into the evidence locker at the Sheriff's Office.

There is no suspect information at this time.

There is nothing further to report at this time.
