**RESOLUTION CERTIFYING PERSONS REQUIRED TO FILE
STATEMENTS OF ECONOMIC INTERESTS PURSUANT TO
THE ILLINOIS GOVERNMENTAL ETHICS ACT**

WHEREAS, pursuant to the Illinois Governmental Ethics Act, 5 ILCS 420/1-101 *et seq.*, certain persons elected to office and certain persons employed by a unit of local government must file a verified written statements of economic interests with the county clerk each year; and

WHEREAS, pursuant to Section 4A-106 of the Illinois Governmental Ethics Act, on or before February 1 annually, the chief administrative officer of a unit of local government shall certify to the county clerk a list of names and addresses of persons elected to office or employed by the unit of local government required to file a verified written statements of economic interests with the county clerk.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF UNION, ILLINOIS AS FOLLOWS:

SECTION 1: The following shall be certified to the Union County Clerk as the names and addresses of persons elected to office or employed by the County of Union, Illinois required to file a verified written statements of economic interests with the Union County Clerk pursuant to Article 4A of the Illinois Governmental Ethics Act, 5 ILCS 420/1-101 *et seq.*:
