**RESOLUTION AMENDING UNION COUNTY GOVERNMENT HOLIDAYS
FOR THE 2019 CALENDAR YEAR**

WHEREAS, pursuant to Chapter 1, Article 7, Section 3 of the Code of Ordinances of Union County IL, the Union County Board of Commissioners shall establish observed holidays each calendar year; and

WHEREAS, the Board of Commissioners of the County of Union, Illinois passed Resolution 2018-38 on December 14, 2018 establishing observed holidays for the 2019 calendar year; and

WHEREAS, the Board of Commissioners of the County of Union, Illinois have determined that Resolution 2018-38 should be amended to include Christmas Eve.


