We are denying your request in part. Please be advised of the following:

- (1) We are denying a portion of the records responsive to your request. Per Section 7(f) of FOIA (5 ILCS 140/7(f)), preliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed or policies or actions are formulated are exempt from release. Additionally, records regarding job applicants prior to hire are exempt under Section 7(c) of FOIA (5 ILCS 140/7(c)) as approved in Public Access Opinion No. 11-003 (Request for Review 2011 PAC 12170).
- (2) Public Information Officer Rollie Hawk is the person responsible for this denial.
- (3) You have the right to review by the Public Access Counselor. Her contact information is below.


