Please consider this our response to your attached Freedom of Information Act request, received via postal mail on August 18, 2020 and summarized below:

Police Report UC200619033.

We are denying your request. Please be advised of the following:

- (1) We are denying your request for these records as they relate to a pending case or cases and as such disclosure would create a substantial likelihood that a person will be deprived of a fair trial or an impartial hearing pursuant to Section 7(1)(d)(iii) of FOIA (5 ILCS 140/7(1)(d)(iii)). By releasing the requested records under FOIA, there would be no restriction where they could be disseminated: print media, social media, etc. As such, to release them under FOIA would serve to create a strong potential that any juror would be exposed to said records prior to any trial.
- (2) Public Information Officer Rollie Hawk and Union County State's Attorney Daniel Klingemann are the persons responsible for this denial.


