We have neither custody nor possession of records responsive to your request.

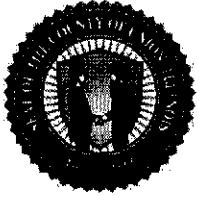
We consider your request completed. If we can be of further assistance, please let us know.
