

NOTICE OF 2020 ASSESSMENT CHANGES

The following is a list of all Real Estate assessments for Townships 11S-1W, 11S-2W, 11S-3W, 11-4W, 12S-1W, 12S-2W, 12S-3W, 12-4W, 13S-2W, 13S-3W located in Union County. The remaining Township assessment changes are located in the Quadrennial Reassessment Publication. All assessed values are subject to revision by the Board of Review and State Equalization. All properties are subject to equalization in accordance with Section 9-210 of the Property Tax Code other than those assessed as farm and coal under Sections 10-110 through 10-140 and 10-170 through 10-200 of the Property Tax Code.

This publication, which is made in accordance with section 12-10 of the Property Tax Code, serves as public notice to property owners that the median level of assessment in Union county for 2020 payable 2021 is 33.51% based on three years of sales transactions from 2017-2019. The statutory median level of assessments is 33.1/3% of fair market value.

You may check the accuracy of your assessment by dividing your assessment by the median level of assessment. The resulting value should equal the estimated fair market value of the property. If the resulting value is greater than the estimated fair cash value of your property, you may be over-assessed. If the resulting value is less than the fair cash value of your property you may be under-assessed. The equalized assessed value is used in the calculation of all Real Estate Tax bills.

Property owners who consider their property incorrectly assessed may file a complaint in writing with the Union County Board of Review in accordance with section 16-55 of the Property Tax Code. All complaints must be filed with the Supervisor of Assessments Office within 30 days following the date of this publication at 309 W. Market St., Rm. 128, and Jonesboro, Illinois 62952.
