Report for Incident 2020-005527, Property Damage, document created on 12/19/2020 @ 13:31:00

On December 18th, 2020 I Deputy Vicente with the Union County Sheriff's Office spoke to a walk in by the name of David L. Williams regarding property damage.

I activated my department issued body camera and spoke to the David. David stated that him and his wife were living with a family friend at [REDACTED] road Goreville, IL in Union County due to their house burning down. David stated that he advised Martin not to drive his truck. On 12/09/2020 his wife Tina Williams and himself left Martin's residence and states that approximately 40 minutes after they left they received a voicemail from Martin stating she had just wrecked David's truck. David states that when they arrived back to Martin's residence Martin was "passed out in the driver seat". David states that Martin, Tina, and himself all talked about the incident and they all agreed not to involve law enforcement. David stated that Martin agreed to not turn the accident into their insurance because Martin agreed to pay for the damage of the truck. David stated that when they advised Martin of the \$10,000.00 estimate. Martin has since blocked their phone numbers. David stated they spoke to their insurance regarding the incident and also pictures of the truck.

Tina called the Union County Sheriff's to confirm the incident because the truck is registered to her. While on the phone with Tina she advised she also ordered Christmas gifts that were delivered to Martin's and is wanting to get them. I advised Tina I would attempt to call Martin to make arrangements for pick up. I made contact with Martin she stated the gifts were on the porch and Tina could pick them up now. I then contacted Tina and she stated she was going to pick them up now.

I waited for Tina for over an hour at [REDACTED]. Tina did not show while I was there, I then interviewed Martin. Martin stated she was given permission from David to use his truck. Martin stated she drove down to her pole barn approximately ¼ of a mile from her residence and stated the truck began to “pull” to the left which caused her to hit a tree. Martin stated she offered to pay for the tow truck but states David stated it was covered by the dealership. Martin stated that she told David and Tina to turn it in to their insurance so they could contact her insurance. Martin also stated there were no witnesses at the time of the accident.

Please see attached body camera and statements for further. I have not received any emails from David or Tina regarding the screenshots and photographs of the truck.
