Chairman Don Denny: All those in favor say aye opposed none. Motion carried.

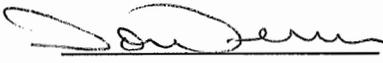
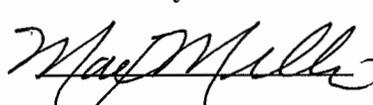
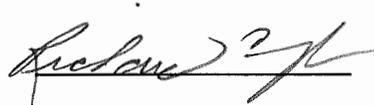
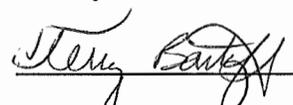
Time returning to open session: 10:34 a.m.
